Grand Champion Points

At the judge's discretion, Grand Championship points may be awarded to: Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch.

Judge's Awards of Merit

Immediately following the Best of Breed Competition, Awards of Merit may be awarded to those dogs or bitches not winning Best of Breed or Best of Opposite Sex to Best of Breed or Best of Winners or Select Dog and Select Bitch, but are deemed of such outstanding quality as to deserve recognition. Best of Breed, Best of Opposite Sex, Select Dog and Select Bitch may not be considered by virtue of their already higher placement. The maximum number of such awards of merit shall be limited to 10% of the total entry in Best of Breed. (The percentage will not be rounded up.)

Reserve Winners Dog and Reserve Winners Bitch Majors

At the national specialty, dogs designated Reserve Winners Dog and Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex total at least twice the number required for a five-point major in the region in which the event is held.

Dogs must be handled in the class by the registered owner of the dog, and this class is limited to exhibitors who have not. at any point in time, been a professional dog handler, AKC approved conformation judge, or employed as an assistant to a professional handler. (eff. 1-1-09)

NOTE: Bred By Exhibitor (BBE Class Eligibility): The Bred-by-Exhibitor Class shall be for dogs that are: Six (6) months of age or older as of the first day of the show; not Champions of Record on the date of closing of entries for the show; individually registered with the Americaan Kennel Club as of the date of closing of entries for the show; owned or co-owned by any of the breeders of record as of the date of the closing of entries for the show. The person handling the dog in this class must be a breeder of record and an owner of record of this dog. In any subsequent classes for which a dog from the Bred-by-Exhibitor Class becomes eligible, there are no restrictions as to who may handle.

NOTE: Best of Breed: The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record, also dogs which according to their owner's records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship according to the owner's records. Brood Bitch Class: Same as Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

NOTE: *Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that a neutered male may be entered as a Stud Dog in the Stud Dog Class and a spayed Bitch may be entered as a Bood Bitch in the Brood Bitch Class.

Brace Class: Each Brace shall be composed of 2 PBGVS, irrespective of sex, owned by an identical owner. Entry fee is \$25.00 for the unit. If the dog that is part of the Brace is not entered in another Class, it must be entered for "Brace Class Only". For a dog for which this is an additional class, indicate Brace in the "Additional Entry" portion of the entry form. If more than one Brace is entered by identical owner, the dog comprising each Brace Unit must be designated "Brace #1", "Brace #2, Etc. Entry fee \$30.00 for each Brace, not each individual.

NOTE: (eff. 1-1-05) A brace is defined by AKC as two dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers. Both dogs competing in Brace competition must have at least one common owner.

Team Class (National Specialty Only): The 4 PBGVs with identical ownership comprising a Team must be named at the time of the entry, only a single entry fee for the Team Class is required. If a dog, which is to be part of a Team, is not entered in a single-class entry, it must be entered for 'Team Class Only'. In making entries for 'Team Class Only' full particulars must be given for each dog on individual regular entry forms. An entry form for each dog entered in another class and entered also as part of a Team must be designated 'Team Class' in the space for Additional Class. If more than one Team is entered by the same owner, the dogs comprising each Team must be designated "PackTeam #1", "Team #2", etc. Entry Fee: \$30.00 for each Team, not each individual.

Pack Class (National Specialty Only): The Pack consists of an entry of at least 6 PBGVs that are all bred, co-bred, owned, or co-owned by the exhibitor. The entry is made in the name of the kennel represented by the dogs as well as the exhibitor's name(s) The dogs are brought into the ring by up to 2 handlers, one of which must be the named exhibitor. The dogs will be judged on a point system with 120 being the maximum. Half the points (60) are allotted for how well the Pack corresponds to breed type, and the other half (60) are allotted on the size (30) and color (30) of the whole. The dogs are judged as a Pack rather than as individuals; they are judged on type, size, and color as a whole; they are not gaited. All dogs judged in the Pack Class must be entered in another class and entered as part of the Pack, must be marked Pack Class in the space provided for 'Additional Class'. If more than one Pack is entered by the same owner, the dogs comprising each pack must be designated "Pack #1", "Pack #2", etc. Entry Fee: \$30.00 for each Pack, not each individual.

As the Judge's decision in the Stud Dog. Brood Bitch. Brace. Team. & Pack Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in these classes will be eligible to compete for Best of Breed by virtue of having won these classes.
